A provisional member ID and password will be assigned to the new member and they will be advised of same by the TMA National Office. All applications are considered by the TMA Australia Board for approval. Once approved, the new member's details are sent to the TMA Global Office (in Chicago) where they will be added to the international membership directory and a permanent membership number will be assigned. Please note that during the approval process, provisional membership will receive member pricing when registering for events. However, their profile will not be visible on the membership directory.*
